## Guidelines for OTED applicants who have undergone a curriculum review with the 2013 ACOTE standards:

In some instances, a standard that was found deficient in the educational comparability review can be met through completing Professional Development. In your determination you were notified which standards can be met through Professional Development, and which standards must be met through academic coursework from an accredited college or university.
